



## **Damage Assessor**



When you have located your car in the parking area, please take a close look at the car to make sure all damages are marked in the rental contract, as described below.

If you find any damages that is not marked on the rental contact, you are obligated to inform the rental office about the damage before leaving the premises so that your rental contract can be updated.

We use the damage assessor shown on the left to evaluate if the exterior damage is chargeable or not. All damages bigger than the measurements on the damage assessor is considered chargeable.
